**Subject:** I&RS 2020 September Enhancement Release

## Overview:

As part of our ongoing effort to support industry requests, the Insurance and Retirement Processing Services ("I&RS") has scheduled an enhancement release for September 2020. This is the second of two scheduled enhancement releases for 2020. I&RS Enhancement Releases include Review Board Enhancement Requests submitted by members and modifications identified by the Producer Alternative Identifiers subcommittee as well as maintenance items National Securities Clearing Corporation ("NSCC") deems necessary to improve the overall operational performance of the systems.

The enhancements include the addition of new information fields on current I&RS record layouts to support new features on I&RS products. Modifications include new fields and code values added to existing code lists.

The enhancements in the September 2020 release will affect the following services and functionalities:

APP/SUB – Applications and Subsequent Premiums

ATT – Attachment/Attachment Access

COM - Commissions

FAR – Financial Activity Reporting

FET – Fee & Exchange Transmittal

IFT – In Force Transactions & IFT Access

IFW – In Force Web Transactions

LNA – Licensing & Appointments & LNA Access

PMP - Producer Management Portal & Access

POV – Positions & Valuations, which is made up to 3 types:

- PVF Positions & Values Full Refresh File
- PNF Positions New Business File
- PFF Positions Focused File

PRP – Positions for Retirement Plans

STL – Settlement for Insurance
