Subject:	ETF PHASE 1 PCF ENHANCEMENTS DEPLOYMENT DATE AND PLAN

As previously announced in Important Notice <u>A8720</u> and subsequent Important Notice <u>A8813</u>, NSCC has been working on enhancing its Portfolio Composition File (PCF) service. The enhancements were developed with ETF Industry Working Groups comprised of ETF Agent Banks and Authorized Participants in response to the proposed ETF Rule 6C-11 which became effective on 09/26/2019. The enhancements include the introduction of multiple basket types to allow flexibility for Create/Redeem order customization, pricing baskets and additional data elements to support the clearance of fixed income ETF's in Phase 2.

The Phase 1 PCF Enhancements have received regulatory approval and will be deployed to production over the weekend of July 25 through July 26, 2020.

The PCF enhancements will be launched in a controlled release over the weekend and will require ETF Agent Banks and Clearing Member Subscribers to submit and receive the enhanced formats. The deployment plan below gives step-by-step instructions. NSCC Product Management will be gathering contact information at client firms of those individuals who will support the deployment and under separate cover send out invites for checkpoint calls and distribitions.
