Subject:	Holiday Schedule: Columbus Day, October 11, 2021	

The Depository Trust Company (DTC) will provide limited services on Columbus Day, Monday, October 11, 2021. Clients should be advised of the following changes in DTC's operations for Columbus Day:

#### A. <u>Distributions and Redemptions</u> -

The PAMM Participant Terminal System (PTS) function will not be available on Monday, October 11, 2021. However, IPAs will be able to make updates using PAMM via functions PAM1 and PAM5 in PTS. See **Appendix A and B for a complete list of impacted PTS functions**.

#### B. Reorganizations -

The PSOP (for rights subscriptions) and WARR (Warrants) PTS functions will not be available on Monday, October 11, 2021.

The following DTC Voluntary Reorganization Services will be available to clients for the submission of instructions during normal hours on Columbus Day, October 11, 2021: IVORS, CERR, CMOP, PTOP, PUTS and RCNV. A complete list of available and unavailable PTS functions is presented in **Appendix A and B**.

- C. <u>Settlement Web (SW), Participant Browser Services (PBS), and Participant Terminal System (PTS)</u> will be available on Monday, October 11, 2021 for limited processing and only stock allocations will be made. There will be no US cash allocations on Columbus Day, October 11, 2021.
- D. <u>ISO2022 CAPA</u> messages on Tuesday, October 11, 2021 will not include corporate actions where record date is Monday, October 11, 2021, and payable date is Tuesday, October 12, 2021.
