National Securities Clearing Corporation will have accumulated the allowable transfer tax rebates reported by participants for the period **September 30, 2021** through **December 30, 2021**. The State requires that these amounts be applied to participants' settlement accounts. Accordingly, on **December 31, 2021**, Final Settlement Statements, these amounts will appear as a debit with a code 70 and credit with a code 71 (see NSCC's rule 14-1 Transfer Taxes).
