Pursuant to <u>Important Notice a9003</u> issued by DTCC Global Business Continuity on May 13, 2021, National Securities Clearing Corporation ("NSCC") will conduct a test of our business continuity and disaster recovery plans in compliance with our obligations under Regulation Systems Compliance and Integrity (Reg SCI) testing requirements.

The testing is scheduled to take place over the course of the following three weekends:

- August 28-29
- October 2-3
- October 23-24

Please be advised that during these testing weekends, <u>DTCC production systems will</u> be unavailable between the hours of 5:00AM (ET) Saturday and 8:00AM (ET) <u>Sunday.</u>

As a result of this testing, Wealth Management Services (WMS) will follow a modified production processing schedule during the aforementioned weekends. For details on the revised production processing schedule for your Insurance & Retirement Services application(s), please refer to the attached Appendix.

Regular production processing and access will resume immediately following the exercises.
