Based on the recently issued Executive Order (“EO”) on June 3, 2021, DTCC will remove certain restrictions that were previously placed on securities related to the prior Executive Order 13959.

For the following securities, current trade capture restrictions will remain in place, however, as applicable, deposit, DWAC deposit, pledge and depository chills will be removed, and all settlement and asset servicing will continue, effective June 14, 2021:
