Subject:	Notice of Bank Holiday Charge Collection – Veterans Day

Friday, November 11, 2022 is a bank holiday where U.S banks are closed and the U.S equity markets remain open. NSCC will be presented with increased exposure due to one additional day of trading positions held in Members' portfolios. To address this increased exposure, NSCC will collect an additional 20% of each Member's start of day Volatility charge on Thursday, November 10th ahead of Veterans Day, Friday, November 11, 2022.

This additional requirement will be added to each Member's requirement after the morning clearing fund collection. Any deficit resulting from the additional clearing fund requirement must be satisfied within 90 minutes of notice.
