A. <u>Deposits</u>: Continuous Net Settlement (CNS) Deposits received in the night drop on Wednesday, November 23, 2022 will be available for credit toward CNS settlement obligations on Friday, November 25, 2022. **DTC will not provide record date** protection on deposits made in the night drop on Wednesday, November 23, 2022.

Requests for Withdrawal-by-Transfers (WT): To avoid dividend problems, you are reminded to exclude any securities that are of record on Thursday, November 24, 2022 from your submissions of WTs made by PTS/PBS on Wednesday, November 23, 2022 or by CCF prior to the 8:30 A.M. cut-off on Wednesday, November 23, 2022.
- E. Participant Browser Services (PBS), Participant Terminal System (PTS) and Settlement Web (SW) will be available for limited inquiry functionality only on Thursday, November 24, 2022.
- F. Canadian Dollar Settlement (CDL): **DTC will not provide settlement services on Thursday, November 24, 2022.**
- G. Underwriting Eligibility Services will be unavailable on Thursday, November 24, 2022.
