On October 7, 2022, Fixed Income Clearing Corporation ("FICC") filed a proposed rule change (SR-FICC-2022-007) ("Rule Filing") with the Securities and Exchange Commission ("SEC") pursuant to Section 19(b)(3)(A) of the Securities Exchange Act of 1934, as amended. The purpose of the Rule Filing is to amend the FICC Government Securities Division ("GSD") Rulebook ("GSD Rules"), the FICC Mortgage-Backed Securities Division ("MBSD") Clearing Rules ("MBSD Rules") and the FICC MBSD EPN Rules ("EPN Rules," and together with the GSD Rules and the MBSD Rules, the "Rules") to: (i) clarify GSD Rules, MBSD Rules and EPN Rules concerning admission to FICC premises, (ii) update EPN Rules related to FICC's maintenance of fidelity insurance bond, (iii) remove outdated EPN Rules related to distribution facilities, and (iv) clarify GSD Rules and MBSD Rules concerning Settling Banks' ability to refuse to settle.
