Subject:	AIP DOCUMENT TRANSFER FUNCTIONALITY & ADDITIONAL INDUSTRY ENHANCEMENTS - 2022

Effective **Friday, November 18, 2022** National Securities Clearing Corporation (NSCC) will implement enhancements to the Alternative Investment Product Services ("AIP") into Production subject to receiving all necessary regulatory approvals. AIP is scheduled to migrate the new coding and fields into Production on Thursday, November 17, 2022 <u>after</u> the 7:00pm (ET) End of Day Processing Cycle.

AIP will provide enhancements to:

- Transmit PDF documents via SFTP or NDM for Purchase, Redemption, Transfer or Maintenance transactions that are stand-alone or related to an AIP transaction; the PDF document will be sent with a 'Manifest' in a Zip file
- Support purchase Orders for delayed NAV products that are becoming more common for BDC and other fund structures where the trade date and money settlement occur weeks before the NAV is finalized
- Indicate the tax structure of products via the Security General Profile

Below is a comprehensive description of the enhancements that will be incorporated into this release. The updated AIP Industry Enhancement Document and Data Dictionary 20.0 will be posted to the AIP website on or about August 29, 2022. A link will be provided to the Industry Enhancement Document and Data Dictionary 20.0 that identifies the impacted records, fields, and values as part of this release.
