Subject:	Mutual Fund Profile Service II – Profile Security: Not In Document (NID) Review and Acknowledgement

In March, 2020, NSCC introduced a process requiring Funds to review and acknowledge Not In Document ("NID") datapoints in Mutual Fund Profile Service II – Profile Security (<u>Important Notice a8825</u>). This periodic acknowledgment process was introduced to assist Funds in the review process and to ensure the NID data points remain current and provides firms with added confidence-in their accuracy. Phase One, review and acknowledgement of non-extractable data points, commenced on April 15, 2022 (<u>Important Notice a9121</u>).

**Effective June 30, 2023,** NSCC will set the status of Social Code eligibility NID data points (Phase Two) to "Review Required", except for those social code NID data points that were acknowledged on or after June 30, 2022. NID data points acknowledged on or after June 30, 2022, will be set to "Review Required" on the **applicable** review date, which is defaulted to a maximum of 365 days but can be adjusted to a lower threshold by the Fund. For example, if a NID datapoint with an annual review period was acknowledged on July 1, 2022, the status will be set to "Review Required" on July 1, 2023.

While Fund clients will be able to acknowledge all their NID data points, the status of those data points **requiring review and acknowledgment** will occur in the following phased approach:

- Phase One: Non-extractable data points, excluding social codes data points that are never disclosed in a document (for example, Blue Sky data) Commenced April 15, 2022
- Phase Two: Social Code eligibility data points Commencing June 30, 2023
- Phase Three: Extractable Data points data points that are normally extractable but are silent in the most recent document filing Commencing Q1 2024

A notification will be distributed prior to Phase Three going into effect.



Similar to Phase One, the number of security issue id's NID data point attribute combinations requiring review and acknowledgement will be included in the daily summary notification e-mails. For example, if there are 20 security codes and each one has 5 social code data points requiring review (Eligible Social code, Eligibility Code, Eligibility date, Number of Active Participant Minimum and Maximum Size for Eligibility), the number provided in the notification will be 100.



While the NID data points and review process are not factored into the quality index score, Funds will continue to receive the notifications for outstanding reviews with their daily summary emails until such time as the data points have been acknowledged. These items can be reviewed and updated either individually or by a bulk acknowledgement process.
