Pursuant to [Important Notice a9409](#) issued by DTCC Global Business Continuity on May 20, 2024, National Securities Clearing Corporation (“NSCC”) will conduct a test of our business continuity and disaster recovery plans in compliance with our obligations under Regulation Systems Compliance and Integrity (Reg SCI) testing requirements.

The testing is scheduled to take place over the course of the following three weekends:

- August 17 -18
- September 14 - 15
- October 5 – 6

**Please be advised that during these testing weekends, DTCC systems will be unavailable between the hours of 5:00AM (ET) Saturday and 8:00AM (ET) Sunday.**

As a result of this testing, Wealth Management Services (WMS) will follow a modified processing schedule during the aforementioned weekends. For details on the revised processing schedule for Mutual Funds Service application(s), please refer to the attached Appendix.

Regular processing and access will resume immediately following the exercises.

## Appendix A

### Key Points - Reg SCI Production Processing Schedule for Mutual Funds

- Production for the following products will run on a modified Saturday schedule (PSE does not run on Saturdays and is not impacted):
  - Networking
  - Omni/SERV Activity & Position, 529 Aggregation
  - Payment aXis
  
- The cutoff time to submit files to DTCC (mainframe and web) is Saturday at 5:00am EST, with the exception of the following files which have an earlier cutoff time:
  - Networking Fund Conversions (3:30am EST cutoff) – earlier cutoff due to Fund Conversion processing must complete before Broker Conversion process commences
  - 529 Aggregation (3:00am EST cutoff) – earlier cutoff due to 529 Aggregation processing must complete before 529 Aggregated process commences
  
- All files received by 5:00am EST on Saturday will be monitored to ensure output is processed and distributed before the test commences
  
- Any transactions submitted during the DR test will NOT be processed
  
- Mainframe connectivity to DTCC will be disabled during the test - clients attempting to connect to DTCC during the test will receive a connection error message
  
- DTCC Web Portal users attempting to select a Mutual Fund application during the test will receive an error message
  - Note for Web Portal Users: During the test, the ‘Utilities’ (UTF) facility will be accessible – no Mutual Fund files should be submitted
  
- Normal processing will commence after the test completes at 8:00am EST on Sunday – files submitted after the test completes must have Monday’s date in the DataTrak header or they will be rejected
