**NOKIA OYJ** has announced a cash dividend and Citibank, N.A. acts as the Depository for the Depository Receipt (“DR”) program.

Participants may use DTC’s Corporate Actions Web (“CA Web”) instructions tab to certify all or a portion of their position entitled to each applicable withholding tax rate. Use of this instruction method will permit entitlement amounts to be paid through DTC. By making submissions of such certifications the submitter warrants that it has the required authority to make them, that the party for which the submission is made is eligible therefore, and will indemnify, as applicable, Globe Tax Services, Inc., the applicable depository, the applicable custodian, and other acting, directly or indirectly, in reliance thereon, including for any inaccuracy therein.

All holders will have the opportunity to receive withholding tax relief as outlined in the “Eligibility Matrix”. All uncertified holders will receive this dividend net of the full Finnish statutory withholding tax of 35% with the possibility to reclaim.

Please be aware that new Finnish legislation concerning preliminary tax withholding on dividends came into effect on January 1, 2020 requiring that a tax rate of 50% will apply to all undisclosed Finnish residents. ## FREQUENTLY ASKED QUESTIONS (FAQs)

### GENERAL QUESTIONS

<b>Is this process free of charge?</b>	<b>No.</b> This tax relief assistance service is wholly voluntary and discretionary, and outside the terms and conditions of any applicable deposit agreement. Citibank N.A. undertakes no duty or obligation to provide this service and may reject or decline any or all proposed electing participants or holders in its sole discretion. Fees will be charged for this assistance service of up to \$0.0075 per DR for Long Form reclaims. Reclaims received post deadline cannot be assured and may be subject to a per beneficiary fee as well as other charges, fees or expenses payable by or due to Citibank N.A. / GlobeTax or its agents, including the custodian or tax authorities. In addition, charges may apply to any Long Form claims rejected or not accepted by the custodian. Fees paid to Citibank N.A./GlobeTax may be shared with its agents.
<b>Do I need to submit via ESP to disclose my beneficial owners?</b>	<b>Yes</b> , submission via ESP is required for all rates better than 35%.
<b>Will GlobeTax accept claims filed directly to them by the beneficial owners?</b>	<b>No</b> , GlobeTax only accepts claims filed by the DTC participant who was holding the securities through DTC and only to the extent that DTC has reported these holdings to us as valid record date holdings. Beneficial owners are required to file their claims through the custody chain to the DTC participant of record. All claims not received directly from the DTC participant will be returned to the beneficial owner.
<b>Is the process for tax relief offered by GlobeTax an optional process?</b>	<b>Yes</b> , this is a discretionary, optional service.
<b>Are form 6166s with IRS code ruling 81-100 accepted?</b>	<b>Yes</b> , with a Treasury Determination Letter (TDL).
<b>Does the beneficiary's name on the form 6166 need to match the POA?</b>	<b>Yes</b> , the beneficiary's name on both documents should be identical.
<b>May I submit a trust agreement in lieu of a POA signed by the beneficial owner?</b>	<b>Yes</b> , but a limited POA signed by the participant must accompany the trust agreement.
<b>Do I need to physically send any documents to GlobeTax?</b>	<b>Yes</b> , along with the electronic submission we need all required documentation listed in the Eligibility Matrix in hardcopy form for Long Form.
<b>What is the statute of limitations for filing Finnish reclaims?</b>	It is 3 years from the end of the year in which the dividend pays. Claims received after submission deadline will be filed on a good faith basis.
<b>Will the FTA ask for any documents?</b>	The FTA may ask for documentation upon audit for all rates better than 35%. For treaty benefits that documentation would likely include a certificate of residence dated the year of ORD payment date, for the 25.5.% rate it may be a tax ID card or another form of government issued id.
<b>How should reclaims be filed for partnerships?</b>	Clarification received in February 2024 confirmed non-resident partnership reclaims should be filed in the name of partnership (upper-level fund) rather than on behalf of its unitholder(s) as previously advised. Changes are effective immediately.

## RELIEF AT SOURCE & QUICK REFUND QUESTIONS

Once I submit a relief at source claim, how long will it take to be paid?	Relief At Source claims are paid on pay date.
Will I be paid through DTCC for claims submitted through the Relief At Source & Quick Refund process?	<b>Yes</b> , the only exception is that claims submitted for Quick Refund after the first Quick Refund batch will be paid by check or ACH.
Do I need to physically send any documents to GlobeTax to participate in the Relief At Source & Quick Refund process?	<b>Yes</b> , documentation outlined on the Eligibility Matrix for Relief At Source and Quick Refund must be sent to GlobeTax by the documentation deadline to be eligible to participate.
Does the process have a minimum position requirement per beneficial owner?	<b>No</b> .
How do I initiate the Relief At Source OR Quick Refund process with GlobeTax?	To participate in either process, the requirement for all buckets are elections at DTC and the disclosure and documentation requirements outlined on the Eligibility Matrix.
My client is unable to provide the required documentation by the Relief At Source deadline. May I still submit the claim through ESP?	<b>Yes</b> , you may either participate in the Quick Refund or on-going Long Form processes, within the Statute of Limitations.
What happens to my DRs if I elect at DTCC but do not submit on ESP?	DRs elected at DTCC should match the disclosure submitted on ESP. DRs that have been elected and the corresponding requirements have not been met will be moved the unfavorable 35% statutory rate.
Do I need to disclose beneficial owner details to receive a better rate during the Relief At Source & Quick Refund process?	<b>Yes</b> .

## LONG FORM QUESTIONS

Will I be paid through DTC for claims submitted through the long form process?	<b>No</b> , you will be paid by check or ACH.
Does the process have a minimum position requirement per beneficial owner?	<b>No</b> . There is a minimum fee of \$25 per beneficial owner for standard Long Form claims which may be waived on an exceptional basis for clients reclaiming less than \$50. In such instances a fee of 50% of the reclaimed amount will be applied.
Do I need to physically send any documents to GlobeTax in order to participate in the Long Form process?	<b>Yes</b> , all documents outlined in the Long Form Eligibility Matrix need to be sent to GlobeTax to be considered a valid claim.
