Periodically, it is necessary for Participants, Members, or Issuers to confirm holdings with the Depository Trust Company (DTC), National Securities Clearing Corporation (NSCC), or Fixed Income Clearing Corporation (FICC) for regulatory compliance.

Effective February 24, 2025, to ensure that audit requests are responded to timely and efficiently, audit requests will be required to be submitted electronically and without physical delivery.

Participants, Members, and Issuers may submit their request(s) to the applicable email address, listed below.

Please be aware that all other requirements remain unchanged.

If all requirements have been met, we will attempt to process all requests upon receipt. Should the form be deficient, we will notify the designated audit contact.
