<b>Subject:</b>	DTCC Fedwire Funds ISO20022 Testing Update

As mentioned in GSD Important Notice GOV1853-24, DTCC requires that member firms work with their payment/commercial banks to test their ability to successfully process Fedwire Fund payments to DTCC. To test successfully, members have been instructed to either have their banks send settlement progress payments and clearing fund/margin wires (as applicable) to DTCC in the Fed's DIT2 environment or submit an attestation that they use a Testing Certified Payment Bank during the testing window of November 4<sup>th</sup>, 2024, through January 31<sup>st</sup>, 2025. DTCC is amending its testing plan as follows:

### **Testing Window Extension**

**The testing window has been extended to February 21, 2025. This is the FINAL extension.**

Please note that this extension coincides with potential code deployments and may impact processing and subsequent evidencing of test wires on Wednesday and Friday mornings in CFM PSE and may require resubmission. **Ideal testing days moving forward will be Monday, Tuesday, and Thursday during business hours.**

Clients are reminded that they need to use the appropriate DTCC wire instructions to receive timely credit for their Settlement Progress Payment and Margin/Clearing Fund wires. DTCC's wire instructions can be found in the appendix of this notice.
