Subject:	FICC Report Center Web Application Modernization

The Fixed Income Clearing Corporation (“FICC”) modernized its FICC Report Center application for the Government Securities Division (“GSD”) and the Mortgage-Backed Securities Division (“MBSD”). This modernization effort moved FICC Report Center to a new platform with a new authentication layer and new URL.

FICC GSD and MBSD Members will need to complete connectivity testing in FICC’s test and production environments to confirm access to the new FICC Report Center URLs. This may require a Domain Name System (“DNS”) configuration of the new URLs to your network.

In preparation for this migration to a new platform, FICC will make access to the new URLs available to GSD and MBSD Members on **Monday, October 20, 2025**, so that Members can verify their access. In addition, a new FICC Report Center tile will be available for selection once logged into MyDTCC Portal. The tile will be labeled ***FICC Report Center (New)***.

Note: The legacy FICC Report Center tile will still be displayed and accessible at this time.

Member firms must configure their DNS to the new URLs, if applicable, and submit their verification of access to FICC **no later than January 16, 2026**.

Please note the following:

- Users should access the new URLs through Google Chrome or Microsoft Edge. Users should **not** use alternative web browsers to access the new URLs.
- The [FICC Member Network Connectivity Options for RTTM Web guide](#) is available to users before the testing window opens. Please refer to the guide for information on how to reconfigure your network to access the new FICC Report Center URLs. Users must have login credentials to the DTCC Learning Center to access the guide.
- The legacy FICC Report Center application will run in parallel with the new FICC Report Center in the MyDTCC Portal until **Friday, January 30, 2026**.
- Effective on **Monday, February 2, 2026**, the legacy FICC Report Center application will not be accessible to Members. Therefore, we encourage all users to confirm their access to the new URLs as soon as possible to avoid disruption of access.

DTCC offers enhanced access to all important notices via a Web-based subscription service. The notification system leverages RSS Newsfeeds, providing significant benefits including real-time updates and customizable delivery. This change will have an impact on all GSD and MBSD Members that access FICC Report Center via DNS.

Next Steps:

- On October 20, 2025, impacted users should begin verifying their access to the new FICC Report Center URLs for both the test and production environments.
- For users that are not successful in accessing the new FICC Report Center URLs, please contact your IT/Connectivity team for assistance prior to reaching out to the FICC Integration team.
- Upon verification of access, a representative from each impacted firm will need to provide an email to the [FICC Integration team](#) stating they have successfully accessed the new FICC Report Center URLs along with the associated accounts they represent.
- Confirmation of access must be submitted to the FICC Integration team by January 16, 2026.
