## Please note that Important Notice MBS# MBS1394-24 dated March 07<sup>th</sup>, 2025 is hereby amended as highlighted below.

The Mortgage-Backed Securities Division of the Fixed Income Clearing Corporation ("FICC/MBSD") will conduct the annual test of its business continuity and disaster recovery plans on October 25, 2025 in compliance with its obligations under Regulation Systems Compliance and Integrity (i.e. Reg SCI DR testing). Select Participants have been designated by FICC/MBSD (based on service usage) to take part in this testing. They will be notified by direct email accordingly by December 31, 2024.

Additionally, FICC/MBSD is expanding its disaster recovery exercise calendar to accommodate enhanced resilience testing both internally and externally (with Designated Participants)<sup>1</sup>. The following dates represent the planned 2025 exercise dates in which normal production schedules will be impacted and anticipated client participation:

During these testing weekends, FICC/MBSD's systems will be unavailable for processing between the hours of 5:00AM (ET) Saturday and 12:00PM (ET) Sunday. For the March 29, 2025 test weekend alone, FICC/MBSD's systems will be unavailable for processing between the hours of 12:00PM (ET) Saturday and 12:00PM (ET) Sunday. Regular processing and access will resume immediately following each exercise.

Designated FICC/MBSD Participants using the SMART Network are also required to test connectivity between their alternate locations and DTCC data centers at least once a year. This can be performed during the planned DR tests or alternatively, on a separately scheduled weekend. Scheduling of a backup connectivity test on an alternative weekend can be arranged by contacting DTCC (at least three weeks in advance of a planned test) by emailing a request to clientconnect@dtcc.com. These tests should be completed by October 31, 2025 to avoid year-end freezes and year-end processing.

Recognizing the criticality of this effort and the importance of regular testing, pursuant to FICC/MBSD's Rules, FICC/MBSD will impose a fine on those designated FICC/MBSD Members who, having been notified that they were required to test in the mandatory Reg SCI Industry exercise, fail to complete mandatory test requirements.

Note that any FICC/MBSD Member not required to conduct a network connectivity test is encouraged to do so, and if such test is successfully completed, written notification of such action will be provided by DTCC. FICC/MBSD does not entertain requests for voluntary Reg SCI DR test participation.

Mandatory Reg SCI Industry testing will continue to take place on an annual basis. We will share details about 2026 scheduled testing as they become available.
