Subject:	ACATS-Fund/SERV® - Eliminate T+2 Acknowledgement Pend Day

NSCC's Automated Customer Account Transfer Service (ACATS) Product Management issued Important Notices <u>a9463</u> and <u>a9574</u> announcing enhancements covering the removal of the Settle Prep Day and ACATS-Fund/SERV T+2 Acknowledgement Pend Day, **effective October 17, 2025**. These enhancements will shorten the time it takes to complete an account transfer. This Notice focuses on the enhancements specific to removal of the ACATS-Fund/SERV T+2 Acknowledgment Pend Day.

To align with the removal of the Settle Prep Day, the ACATS-Fund/SERV T+2 Acknowledgement Pend Day will be eliminated, reducing the **period to acknowledge an ACATS-Fund/SERV transfer from two days (T+2) to one day (T+1)**. All mutual fund transfers will be required to be acknowledged by 11:00am ET on T+1 (the next business day) after receipt of the ACATS Transfer 018 record. If NSCC does not receive the acknowledgement by the 11:00am ET cutoff time on T+1, the transfer will be deleted from the system.

In conjunction with the removal of the T+2 Acknowledgement Pend Day, NSCC will no longer distribute ACATS-Fund/SERV Reminder (080) records on T+1, as it will no longer apply since the T+2 Acknowledgement Pend Day is being eliminated. Please see Appendix for updates to the 080 record.

Effective dates for elimination of the T+2 Acknowledgement Pend Day & 080 Reminder:

 Removal of the T+2 Acknowledgement Pend Day will become effective for ACATS Transfer (018) records distributed by NSCC on or after Friday, October 17, 2025.

DTCC offers enhanced access to all important notices via a Web-based subscription service. <u>Example</u>: An ACATS Transfer 018 record received by the Fund on Friday, October 17, 2025 that is not acknowledged or rejected by 11:00 AM ET on Monday, October 20, 2025 will be deleted from the system.

Because of the shortened response time, Funds should consider adjusting their review practices of ACATS to an earlier timeframe.

• The ACATS T+2 Acknowledgement Pend Day will remain in effect for ACATS Transfer (018) records distributed by NSCC on or before, Thursday, October 16, 2025.

<u>Example</u>: An ACATS Transfer 018 record received by the Fund on Thursday, October 16, 2025 will remain open until 11:00 AM ET on Monday, October 20, 2025. If the transfer is not acknowledged or rejected by 11:00 AM ET on Monday, October 20, 2025, the ACATS Transfer will be deleted from the system.

• Effective Monday, October 20, 2025 NSCC will no longer distribute ACATS-Fund/SERV Reminder (080) records on T+1. The reminders were distributed to alert Funds of transfers that were not acknowledged by 11:00am ET on T+1. Since the T+2 Acknowledgement Pend Day is being eliminated, the reminder no longer applies. Funds that have a system dependency on this record should take appropriate action.

TESTING

Effective Friday, July 25, 2025 clients can begin testing in the Participant Services

Environment (PSE) region. Clients are strongly encouraged to test and must contact their

Relationship Manager before testing begins if access to the PSE region has not been previously established.
