Subject:	FAST Reject and Confirmation System (FRAC) functionality – FAST Underwritings on the Securities Processing Application (SPA) System – Implementation Schedule – User Roles and Entitlements

On November 21, 2024, through Important Notice B#21022-24, The Depository Trust Company ("DTC") announced the next phase of its Securities Processing Transformation Program ("SPA"), Direct Registration System ("DRS") Transformation. The announcement included the availability of FAST Reject and Confirmation System ("FRAC ") functionality on the SPA system, used by Transfer Agents to confirm new issue FAST Underwritings.

DTC is pleased to announce that, subject to regulatory approval, the FRAC functionality for new issue FAST Underwritings will be available in the SPA system's Participant Simulated Environment ("PSE") test region on August 7, 2025. This will enable Transfer Agents to conduct testing ahead of DTC's planned Production release and go-live in October 2025.

FRAC functionality will continue to be available in DTC's legacy platform, for Withdrawal by Transfer and Physical Shipment Control List ("SCL") processing, until these functions transition to the SPA system.

User Roles and Entitlements

FRAC entitlement roles are now available for provisioning for PSE and Production ("PROD") regions of the SPA system. Please obtain the entitlement roles (outlined below) in advance of FRAC functionality becoming available.

Access and entitlements to the SPA system must be provisioned by the user's designated Super Access Coordinator ("SAC"). If SACs have any questions about how to provision access though the

Detailed descriptions of new user access roles and entitlements will be announced before each component functionality PSE date through separate Important Notices. After provisioning, functionality testing for user access entitlements will be available with each component rollout and will continue until go live. Firms must enable users at each component interval to ensure a smooth onboarding experience.
