<b>Subject:</b>	UNIVERSAL TRADE CAPTURE EXCHANGE TESTING FOR 24X NATIONAL EXCHANGE (24X)

As a part of its launch preparations, the 24X National Exchange (24X) is to conduct client industry-wide testing that will commence on August 23, 2025. Clients are advised that NSCC will be supporting that testing via its Universal Trade Capture (UTC) application in the Participant Services Test Environment (PSE). UTC will accept the input of test trades from 24X and provide its customary output reporting to clients with the test data. Further details are as follows:

**UTC Testing Details for 24X**

NSCC will modify its output reporting to account for the new exchange. The 24X Exchange market code will be '175' in UTC output (FIX tag 30, MRO position 58-60). This is the market code that will also be reported on the Consolidated Trade Summary (CTS). All equity trades will be reported with the Contra Clearing Firm number of 8602 and Contra Executing Broker (MPID) "ANON" in support of post trade anonymity.
