Subject:	ACATS SETTLE PREP REMOVAL / MUTUAL FUND DAY 2 ACKNOWLEDGEMENT REMOVAL – REGULATORY APPROVAL NOTICE AND PRODUCTION REMINDER!

This is a follow-up to Important Notice <u>a9463</u> (dated 7/31/24) and <u>a9574</u> (dated 3/25/25) announcing new enhancements to the Automated Customer Account Transfer Service (ACATS). Enhancements will include: 1) the removal of Settle Prep (status 300), and 2) the removal of the ACATS Fund/SERV Day 2 acknowledgement. This notice serves as a final reminder and a confirmation of regulatory approval of this upcoming production release. Requirements can be found in notice <u>a9574</u> or via <u>dtcclearning.com</u>.

### ACATS Settle Prep Removal - Friday, October 17, 2025

This date is the first day in which a transfer will not stage to 300-settle prep status at the end of the day.

## Fund/SERV Day 2 Acknowledgement Removal - Monday, October 20, 2025

This date is the first day on which funds/transfer agents would not receive an 080-reminder record or be permitted to send a day 2 acknowledgement. Any day 2 acknowledgement will be rejected starting on this date and ACATS will deem it a no response system purge. This is also the first date on which firms will not receive a pending acknowledgement in the Fund/SERV statistical report.
