



DTCC Brings Economies of Scale

In 2015, **DTCC's subsidiaries** processed securities transactions valued at approximately **US\$1.5 quadrillion**.

DTCC's **NSCC** subsidiary is the central clearinghouse for more than **50 exchanges and equity trading platforms** in the U.S.

DTCC's **FICC** subsidiary processes approximately **US\$4 trillion each day** in U.S. government- and mortgage-backed securities transactions.






DTCC


Current Trade Workflow
