Dear Valued Client,

Based on the General License 1A recently issued by OFAC, DTCC will allow normal processing on the following securities through May 27, 2021. The suspensions or restrictions previously communicated to go into effect on January 28 will no longer be applied. All normal activities including clearance, settlement and asset servicing will continue for the 7 securities listed below.
