Real-Time (RT) Balance Order Message

Description:

For T1 accelerated settlement, NSCC will create a new Real-Time (RT) balance order message for any non-CNS eligible trade it received on settlement date. The message will be distributed (via MQ format only) from NSCC's Universal Trade Capture (UTC) application between 4:00 AM ET and CTS Cycle 3 cutoff (or 1:30 PM ET). Since there is no balance order netting performed by UTC for a non-CNS eligible security received on settlement date, each balance order will always settle as Trade-for-Trade (TFT). A Member who consumes this message will be able to obtain their balance order information earlier on settlement date (as opposed to waiting for the CTS Cycle 3 distribution). Attached below is a copy of the message format.

Additional information is as follows:

- The message format is the same Balance Order (BO) record format in CTS MRO Autoroute product #02042339
- For the values highlighted in yellow, that will be the only value used in the output for that specific field in this new message. The values not highlighted in yellow will not be applicable for this message.
- The message will be delivered in MQ format only.
- The CDTS subscription set-up for this message is: **UTCBO**
