SUBJECT:	<b>OBLIGATION WAREHOUSE – FEES EFFECTIVE JULY 1, 2011</b>		

Obligation Warehouse (OW) was launched in production on March 4, 2011 for all full service Members of National Securities Clearing Corporation (NSCC). As approved by the DTCC Board of Directors, NSCC will begin to assess fees for certain services within OW starting with activity on July 1, 2011.

Pursuant to Rule Filing SR-NSCC-2011-05 (the "Rule Filing"), filed with the U.S. Securities and Exchange Commission on Monday, June 20, 2011, the following fees will be added to NSCC's Rules and Procedures. As noted below, the fee for each pending comparison advisory (aged five days or more) will be implemented in a tiered phase-in over the course of the next six months as Members become familiar with the functionality of Obligation Warehouse.
