Subject:	MF Info Xchange Service Enhancements

On **January 31, 2019**, National Securities Clearing Corporation (NSCC) implemented enhancements to MF Info Xchange – the real-time, centralized communications service for the mutual fund industry.

The following changes are now available in both PSE and Production environments:

# 1) Fund Liquidation Notification

This enhancement further expands the types of notifications that can be sent allowing clients to send communications regarding future fund liquidations.

# 2) "Cancellation Reason" field

In the event a previously distributed event is cancelled, a cancellation notification is typically required by intermediaries. The new "Cancellation Reason" field will allow clients to provide a cancellation reason to the consumers of the notification. "Cancellation Reason" field is only required when "Event Status" is set to Cancelled, but not allowed for other event statuses.

#### 3) Distribution List template is available in the portal

Clients are now able to access the distribution list template in the upload format from the portal (Distribution Lists  $\rightarrow$  Upload option in the portal navigation menu).

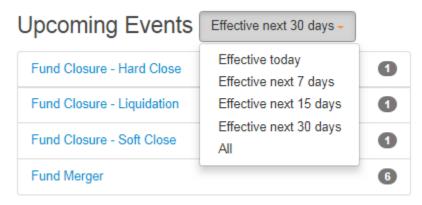
## 4) Revised "Merger Ratio" field description

Description was added to the "Merger Ratio" field to clarify the value contained in this field: "Merger Ratio (the number of Survivor Fund shares for each share of Retiring Fund)".

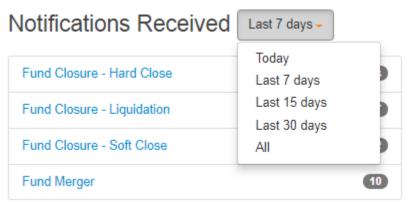

## 5) Enhanced Firm Dashboard

• "Upcoming Events" section will display events grouped by effective date and event type. Clicking on the event name will open the "Search Notification" screen and display notifications based on the selected criteria.



• "Notifications Received" section will display events grouped by distribution date and event type. Clicking on the event name will open the "Search Notification" screen and display notifications based on the selected criteria.
